Course Content

- Unit I: Functions of Education Individual, Social, National, and Global. Types of Education Formal, informal, and non-formal. Interdisciplinary and Transdisciplinary approaches to education. Right to education and its implications. Human Rights Education meaning and significance. Sociological foundation: Education as a social subsystem home, community, modernisation, politics, religion, culture, democracy, and child. Education and social change, constraints on social change (caste, ethnicity, class, language, religion, population, and regionalism)
- Unit II: Meaning, nature, and functions of educational psychology. Relevance of educational psychology to teachers, learners, teaching, and learning. Growth and development concepts, principles, and stages. Dimensions of growth and development physical, cognitive, social, moral, and emotional. Psychological needs of children. Motivation meaning and significance. Types of motivation, Strategies for enhancing motivation in learners
- Unit III: Pedagogy Pedagogical Analysis Concepts and Stages, Critical Pedagogy meaning and need. Curriculum construction and development, Curriculum evaluation interpretation of evaluation results. Assessment Meaning, Nature, and Types (placement, formative, diagnostic, and summative). Relationship between objectives and outcomes. Concept and principles of guidance and counselling, types of guidance (educational, vocational, personal, health, and social) and counselling (directive, non-directive, and eclectic).
- Unit IV: Innocence and helplessness vs naughty and mighty. Childhood debate old concepts vs new concepts. Presumption of innocence dignity, participation, the child's best interest, family responsibility, safety, equality and non-discrimination, right to privacy, and confidentiality.
- Unit V: Provisions under Indian Constitution Fundamental Rights, Directive Principles and Fundamental Duties), Constitution Amendments, Child rights major provisions under the Indian Penal Code, Landmark judgments related to the protection of child rights.
- Unit VI: UN Convention on the Rights of the Child (UNCRC). Important Child Rights Legislations in India. The Protection of Children from Sexual Offences Act, 2012. Child Rights Commissions: NCPCR, SCPCR's, Children's Court. Right to Education, Legal Services Authority Act, Pre-natal diagnostic techniques, Medical Termination of Pregnancy Act 1971.
